# 1. Land Acknowledgement

Jeff Ward sared a land acknowledgement statement: "We would like to begin by acknowledging that we are in Mi'kma'ki, the ancestral and unceded territory of the Mi'kmaq People. This territory is covered by the "Treaties of Peace and Friendship" which Mi'kmaq and Wəlastəkwiyik (Maliseet), and Passamaquoddy Peoples first signed with the British Crown in 1725. The treaties did not deal with surrender of lands and resources but in fact recognized Mi'kmaq and Wəlastəkwiyik (Maliseet) title and established the rules for what was to be an ongoing relationship between nations...We are all Treaty People."

### 9. YMCA of Cape Breton Constitution

Mark Galley shared that the Board of the YMCA of Cape Breton made it a priority in the fall of 2020, to begin the process of reviewing the Association's existing by-laws and bring them up to date with governance best practices. The Association immediately enlisted the support of YMCA Canada volunteer and governance expert, Don McCreesh, to join us on this journey.

Over the 18-months, the Governance Committee suggested revisions to ensure the following:

- Ensure legal compliance with applicable laws
- Ensure compliance with internal governance practices
- Ensure the presence of sound governance practices
- To move certain provisions into a separate policy document which we call the Governance Guidelines for the YMCA of Cape Breton; and
- To guide the board in meeting its responsibilities.

The YMCA of Cape Breton has been governing under a set of by-laws as well as a constitution for decades. Mark explained that the use of a "Constitution" is a legacy concept and generally predates the use of By-Laws. It is generally felt that organizations that still have constitutions and by-laws leads to confusion as they serve essentially the same purpose. That is, the direction, guidelines and limitations prescribed by members as to functioning of the governance and management of an organization. These days the vast majority of organizations use only by-laws.

By dissolving the YMCA of CB Constitution, the Association is essentially making that document no longer "active" and no longer one of the governing documents but to be relegated to the archives. The board would like to assure you that all of the key "directives" contained in the old Constitution are replaced in the on-going governance documents (primarily the by-laws) - and that has been accomplished through the work of the Governance Committee over the past 18 months and through the proposed by-laws in the next agenda item. All members would have received copies of the current constitution in their meeting package as well as a copy of the proposed by-laws.
